#### Highlights:

- Current Members: 76

- Several monetary contribution have been made by the Friends to the NWPL in the past year which totaled \$6,265.

## **Vermont Community Foundation: Emilye Pelow Corbett**

Highlights:

She provided two handouts:

- Closing the Opportunity Gap
- Supporting Vermont Nonprofit Organizations

They support nonprofits in three ways:

- Helping to find donors and to support the process of donations
- Support to nonprofits on planned giving and grants
- Research
