

<u>Library of Things Borrower's Agreement</u>

- 1. Patrons must be aged 18 or over and be a patron in good standing in order to borrow items from our "library of things" collection.
- 2. Prior to borrowing an item, all Patrons must sign this Borrower's Agreement and Waiver Form. 3. By taking possession of any item, the Patron is certifying that he or she is capable of using that item in a safe and proper manner.
- 4. Only the Patron is authorized to use the item unless by the express permission of the Library.
- 5. Unless otherwise specified, the loan period will be two weeks. Patrons may borrow up to three items at a time.
- 6. All items borrowed are to be returned inside to the Library circulation desk.
- 7. The Library may replace severely delinquent (i.e. unreturned) items, holding the Patron responsible for the full replacement cost.
- 8. The Patron agrees that the Library is not responsible for any manufacturing defects in quality of workmanship or materials inherent in any borrowed item.
- 9. The Patron agrees that if any borrowed item becomes unsafe or in a state of disrepair, Patron must immediately discontinue use and notify the Library of the issue upon return.
- 10. All items are to be returned in the same (or better) condition as they were issued, barring normal wear and tear.
- 11. The Patron agrees to report any damage to the Library immediately. The Patron also agrees to pay for the loss of or damage to any item and to accept the Library's assessment of condition of items and to further agree to the Library's assessment of fair restitution for damage.
- 12. The Library reserves the right to refuse the loan of any item at its discretion.
- 13. I state that I have read and fully understand the Library of Things Borrower's Agreement and Use Policy of the Norman Williams Public Library (NWPL), and I understand that failure to comply with any of these rules may result in revocation of my borrowing privileges. I have read and signed a Waiver and Indemnification form, relinquishing any and all claims against The NWPL.
